In addition to our fees there are a number of payments that may need to be made to third parties. These may include:

- a) Immigration Application Fees. These are standard application fees that have to be made to the Home Office for various applications that are made to them. The amount of fees payable is published on the Home Office website.
- b) Immigration Health Surcharge. This is payable on all applications for entry clearance of further leave to remain for periods exceeding 6 months. The amount of fees payable is published on the Home Office website.
- c) Independent Experts Fees. These are for an expert report that may need to be obtained to be filed in support of any application such as an Accommodation Certificate at an approximate cost of £100.00 plus vat
- d) Land Registry Fees. These are for any Office Copy Entries that may need to be obtained to prove ownership of property at a cost of £7.00 per property.
- e) Accommodation Certificate. On some occasions it may be necessary to produce experts' reports to prove that there is sufficient accommodation for the applicant.
